## ORDINANCE NO. 2010- $0^{\circ}$

AN ORDINANCE REPEALING ORDINANCE NO. 2009-23 WHICH (A) AMENDED THE FUTURE LAND USE MAP OF THE PUTNAM COUNTY COMPREHENSIVE PLAN; AND (B) ADOPTED A DEVELOPMENT AGREEMENT WITH STOKES LANDING ENTERPRISES, LLC; REPEALING ALL INCONSISTENT ORDINANCES OR PARTS THEREOF; AND SETTING FORTH AN EFFECTIVE DATE.

WHEREAS, on June 9, 2009, the Putnam County Board of County Commissioners adopted Ordinance No. 2009-23;

WHEREAS, Ordinance No. 2009-23 implemented a Future Land Use Map ("FLUM") amendment changing the classification of the property described on Appendix A hereto (the "Property") from Agriculture II to Industrial;

**WHEREAS**, the FLUM amendment was found by the Division of Administrative Hearings to be "not in compliance"; and

**WHEREAS**, the County wishes to change the FLUM classification of the Property from Industrial back to Agriculture II.

### BE IT ENACTED BY PUTNAM COUNTY, FLORIDA, THAT:

**SECTION ONE.** The Future Land Use Map of the Putnam County, Florida, *Comprehensive Plan* is hereby amended as set forth in Appendix A attached hereto and incorporated herein by reference. Ordinance No. 2009-23 is hereby repealed in all respects.

**SECTION TWO.** The Development Agreement dated June 9, 2009, between Stokes Landing Enterprises, LLC and Putnam County (Exhibit C to Ordinance No. 2009-23) is hereby rendered void.

**SECTION THREE.** In order to make the Putnam County, Florida *Comprehensive Plan*, as hereby amended, available to the public, a certified copy of this enacting Ordinance, as well as certified copies of the Putnam County, Florida *Comprehensive Plan* and the amendments thereto, shall be located in the Planning & Development Services Department of Putnam County, Florida. The Planning & Development Services Director shall make copies available to the public for a reasonable reproduction charge.

SECTION FOUR. The Planning & Development Services Director is hereby authorized and directed to transmit this adopted Comprehensive Plan amendment to

the Florida Department of Community Affairs, Bureau of Local Planning, Plan Processing Team, as specified in the Department's procedural rules, within ten (10) working days of the adoption of this Ordinance, and shall also transmit copies to the Northeast Florida Regional Planning Council, to the St. Johns Water Management District, to the Department of Environmental Protection, to the Department of Transportation, and to any other unit of local government or governmental agency in the state that has filed a written request with the County Commission for a copy of Comprehensive Plan amendments.

**SECTION FIVE.** All Ordinances or parts of Ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION SIX. This Ordinance shall take effect immediately upon its adoption.




