
FINAL ORDER

THIS CAUSE is before me for entry of a Final Order. The Recommended Order concludes that petitioners did not establish that the subject child care facility met the qualifications for licensure under section 402.301, et seq., Florida Statutes, and chapter 65C-22, Florida Administrative Code. The administrative law judge (ALJ) found that petitioners failed to correct deficiencies at the facility that precluded the issuance of a license despite technical assistance from the Department. The ALJ recommended that petitioner's application be denied. No exceptions to the Recommended Order were filed. The Recommended Order is approved and adopted.

Accordingly, petitioners' application for a child care facility license is DENIED.

REVIEW PROCEEDINGS SHALL BE CONDUCTED IN ACCORDANCE WITH THE FLORIDA RULES OF APPELLATE PROCEDURE. THE NOTICE OF APPEAL MUST BE FILED WITHIN 30 DAYS OF RENDITION OF THE ORDER TO BE REVIEWED.


