## FINAL ORDER

A recommended order having been received, this matter is before Department of Health (Department) for disposition. At issue is the three count administrative complaint charging the Respondent, a registered septic tank contractor, with the following statutory and rule violations: one, repair of on an on-site sewage treatment system without first obtaining a permit; two, installation of an on-site sewage treatment system without first obtaining a permit; three, repair or installation of an on-site sewage treatment system without first obtaining a permit.

The Administrative Law Judge finds that counts one and two were proved by clear and convincing evidence. Count three was not proved. The Administrative Law Judge recommends a letter of warning as to count one and imposition of a fine of seven hundred fifty dollars (\$750) as to count two. As to the count three, it is dismissed. The recommended order of November 10, 2009 is adopted and incorporated by reference.

Based on the foregoing, a letter of warning is approved and a fine of seven hundred fifty dollars (\$750) is imposed. Payment in full of the fine is due no later than 30 days after the filing date of this final order.
