FINAL ORDER

THIS CAUSE came on before Alex Sink, as Chief Financial Officer, for consideration of and final agency action on a Recommended Order (attached as Exhibit A) entered by Administrative Law Judge, Daniel Manry. A formal hearing was conducted on February 23, 2010, pursuant to Section 120.57(1), Florida Statutes by video teleconference in Tallahassee and St. Petersburg, Florida. On May 3, 2010, Petitioner, Kim Lashawn Edmonds, filed one exception.

RULING ON PETITIONER'S EXCEPTION

The Petitioner generally asserts that she does not agree with the Administrative Law Judge's recommended decision of denial. However, she fails to state with particularity what findings of fact and/or conclusions of law are disputed. She fails to identify the legal basis for the exception and fails to cite to the record. Therefore, in accordance with Section 120.57(1)(k), Florida Statutes, the Department is unable to rule on this exception.

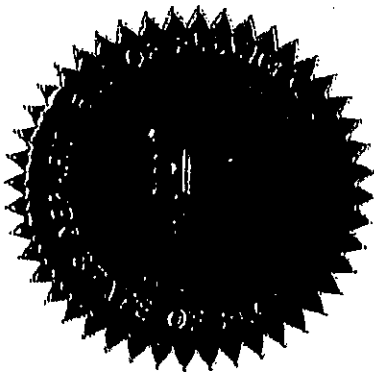
Therefore, after review of the record, including admitted exhibits, and being otherwise fully apprised in all material premises,

IT IS HEREBY FURTHER ORDERED that the Recommendation made by the Administrative Law Judge is adopted by the Department, and that the application for certification as a Firefighter II is DENIED.
