FINAL ORDER

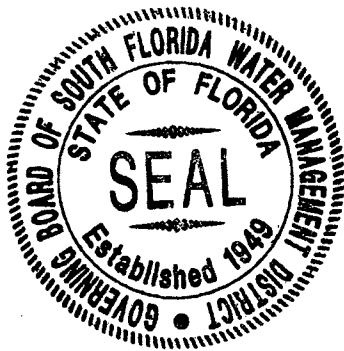
