1. On March 26, 2009, the Department issued an Administrative Complaint attached hereto as exhibit "A."
2. On April 9, 2010, a hearing in this cause was held before the Honorable Suzanne F. Hood, Administrative Law Judge, Division of Administrative Hearings.
3. On May 13, 2010, Honorable Suzanne F. Hood issued a Recommended Order, a copy of which is attached as Exhibit "B." The Statement of the Issues, Preliminary Statement, Findings of Fact, Conclusions of Law, and Recommendation contained in the


Recommended Order are hereby adopted *in toto* and incorporated herein by reference.

1. Respondent shall pay a fine in the amount of \$1,000.00, due and payable to the Division of Hotels and Restaurants, 1940 North Monroe Street, Tallahassee, Florida 32399-1011, within thirty (30) calendar days of the date this Order is filed with the agency clerk.

2. This Final Order shall become effective on the date of filing with the Agency Clerk.


