FINAL ORDER


By Administrative Complaint dated December 1, 2009, the Agency for Persons with Disabilities charged Respondent, Bonnie's Group Home, with three counts of violating Chapter 393, Florida Statutes, and Rule 65G-2.012(23)(c), Florida Administrative Code. The matter was referred to the Division of Administrative Hearings for a hearing. Before the hearing could be held, the parties advised the Administrative Law Judge that a Settlement Agreement had been reached and asked him to dismiss the cause with prejudice. On May 13, 2010, the Administrative Law Judge entered an Order Closing File and relinquished jurisdiction to the Agency for entry of a final order.

Based on the foregoing and being otherwise fully advised in the premises, it is hereby ORDERED that the Settlement Agreement and Release entered into by the parties, a copy of which is attached hereto, is hereby ADOPTED AND APPROVED. The parties shall comply with and be governed by the terms and conditions of the Settlement Agreement and Release. Failure to comply with the Settlement Agreement and Release may result in further judicial proceedings.

Fines provided for in the Settlement Agreement shall be paid to the Agency within ninety (90) days of the date of this Final Order and shall be mailed to:


