FINAL ORDER

FINDINGS OF FACT

- 2. There is competent substantial evidence to support the findings of fact.

4. The conclusions of law set forth in the Recommended Order are approved, adopted and incorporated herein by reference.

WHEREFORE, IT IS ORDERED AND ADJUGED, that the Recommended Order from the Administrative Law Judge is hereby adopted and approved by the School Board and resolves all issues relating to the appeal of Richard Rahey's recommended disciplinary action. Accordingly, the Board hereby issues a Final Order suspending Richard Rahey without pay and terminating his employment with the School Board. This Final Order shall take effect upon being filed with Clerk of the SCHOOL BOARD OF PALM BEACH COUNTY, FLORIDA.
