PARTIAL FINAL ORDER

An Administrative Law Judge of the Division of Administrative Hearings has entered an Order Granting Leave To Amend And Partially Relinquishing Jurisdiction. A copy of the Order is attached to this Final Order as Exhibit A.

BACKGROUND

This is a proceeding to determine whether the portion of Pasco County (County)

Comprehensive Plan Amendment 09-1 adopted by Ordinances 09-24, 09-25 and 09-26 on

December 15, 2009, is "in compliance" with the Local Government Comprehensive Planning and

Land Development Regulation Act, Ch. 163, Part II, Florida Statutes (the "Act").

Pasco County Comprehensive Plan Amendment 09-1 was adopted by Ordinances 09-23 – 09-37. On February 23, 2010, the Department published a Notice of Intent to find all of the Ordinances adopting Amendment 09-1 in compliance. The Petitioners in this case challenged Ordinances 09-24, 09-25, and 09-26. The Petitioner in another case, <u>Devoid v. Pasco County</u>, DOAH 10-1541GM, challenged Ordinance 09-23, and that case remains pending as of the date

of issuance of this Partial Final Order. Ordinances 09-27 through 09-37 were not challenged,

and became effective 21 days after publication of the Department's Notice of Intent.

The Parties in this case jointly moved for leave for the Petitioners to file an Amended

Petition which focused their challenge on Ordinances 09-25 and 09-26, and on a portion of

Ordinance 09-24. The Parties also jointly moved for an order relinquishing jurisdiction over

Ordinance 09-24, except for Section 2.W., and the Administrative Law Judge granted both

motions.

Since there is no pending challenge to Ordinance 09-24, except for Section 2.W., it is

appropriate to issue this Partial Final Order.

ORDER

WHEREFORE, it is ORDERED that:

A. Jurisdiction over Ordinance 09-24, except for Section 2.W. is accepted; and

B. The Comprehensive Plan Amendments adopted by Pasco County Ordinance

09-24, except for Section 2.W., are determined to be in compliance with Part II of

Chapter 163, Florida Statutes.
