FINAL ORDER

An Administrative Law Judge of the Division of Administrative Hearings has entered an Order Closing File and relinquishing jurisdiction in this proceeding. A copy of the Order is attached to this Final Order as Exhibit A.

BACKGROUND

This is a proceeding to determine whether the portion of Pasco County (County)

Comprehensive Plan Amendment 09-1 adopted by Ordinance 09-23 on December 15, 2009, is

"in compliance" with the Local Government Comprehensive Planning and Land Development

Regulation Act, Ch. 163, Part II, Florida Statutes (the "Act").

Pasco County Comprehensive Plan Amendment 09-1 was adopted by Ordinances 09-23 – 09-37. On February 23, 2010, the Department published a Notice of Intent to find all of the Ordinances adopting Amendment 09-1 in compliance. The Petitioner in this case challenged Ordinance 09-23. The Petitioners in another case, <u>Angelos Aggregate Materials</u>, <u>LTD v. Pasco</u>

County, DOAH 10-1540GM, challenged Ordinances 09-24, 09-25, and 09-26, and that case remains pending as of the date of issuance of this Final Order. Ordinances 09-27 through 09-37 were not challenged, and became effective 21 days after publication of the Department's Notice of Intent.

The parties to this case entered into a Stipulated Settlement Agreement which required the County to adopt certain remedial amendments. The County adopted the remedial amendments and the Department published its Notice of Intent to find the remedial amendment to be "in compliance" with the Act. Twenty-one days have passed since the publication of the Notice of Intent, and no petition challenging the remedial amendment was filed.

The Department subsequently filed a Motion to Relinquish Jurisdiction, and the Administrative Law Judge issued his Order Closing File (copy attached hereto).

<u>ORDER</u>

WHEREFORE, it is ORDERED that the above-captioned proceeding is DISMISSED,
Ordinance 09-23 as modified by the remedial amendment is determined to be in compliance, and
the Agency Clerk is directed to close the file.
