## **AMENDED FINAL ORDER**

Having reviewed the Administrative Complaint dated February 12, 2010, and the Amended Notice of Intent to Deny dated July 13, 2010, attached hereto and incorporated herein (Composite Ex. 1), and all other matters of record, the Agency for Health Care Administration ("the Agency") has entered into a Settlement Agreement (Ex. 2) with the parties to these proceedings, and being otherwise well advised in the premises, finds and concludes as follows:

**ORDERED:** 

- 1. The attached Settlement Agreement is approved and adopted as part of this Final Order, and the parties are directed to comply with the terms of the Settlement Agreement.
  - 2. The Final Order in AHCA Case No. 2010000666 is vacated.
- 3. An administrative fine of \$45,000.00 is imposed against the Respondent, Karmoon Sukhraj ("the Respondent"), but is STAYED and the Agency will not collect the administrative fine unless the Respondent violates the terms of the Settlement Agreement. The Agency's Facilities Intake Unit, however, shall maintain an "alert" in its computer system on the Respondent in order to enforce the license prohibition on the Respondent set forth in the Settlement Agreement.
- 4. The Respondent's initial application for licensure as an adult family-care home is withdrawn.
- 5. The Respondent's request for administrative hearing filed in AHCA number 2009012890 is withdrawn.
- 6. The Respondent shall pay, within thirty (30) days of the date of rendition of this Order, attorney's fees in the amount of \$200.00. A check made payable to the "Agency for Health Care Administration." The check, along with a reference to these case numbers, should be sent directly to:
