**FINAL ORDER**

By individual letters dated March 31, 2010, the Agency for Persons with Disabilities (APD) advised Petitioner Angels of America that it intended to deny for various reasons its applications to renew the licenses of seven group homes it operated. Petitioner requested an administrative hearing and the matter was referred to the Division of Administrative Hearings (DOAH).


Prior to the hearing, the parties entered into settlement negotiations and on October 5, 2010, APD advised the Administrative Law Judge that the parties had reached an agreement. On October 8, 2010, DOAH entered an Order Closing File relinquishing jurisdiction to APD for the entry of a Final Order consistent with the Settlement Agreement.

THEREFORE, upon consideration of the Settlement Agreement approved by the parties on October 4, 2010, and being otherwise fully advised in the premises, IT IS HEREBY ORDERED AND ADJUDGED that:

1. The Settlement Agreement, a copy of which is attached hereto, is hereby adopted; and

2. The parties shall adhere to and be governed by the terms and conditions of said Settlement Agreement.


