The parties to this proceeding entered into a Stipulated Settlement Agreement, the City adopted a Remedial Amendment, the Department published a Cumulative Notice of Intent to find the Remedial Amendment in compliance, and no challenges to the Cumulative Notice of Intent were timely filed. The Department filed a Notice of Voluntary Dismissal, and the ALJ

then issued his Order Closing File.


