FINAL ORDER OF DISMISSAL

On May 10, 2010, the Division of Retirement sent a final agency action letter to Petitioner, Hazel J. White, denying her request to submit an application for in-line-of-duty disability benefits. Petitioner timely requested a hearing and the Department of Management Services (hereinafter “Department”) referred the matter to the Division of Administrative Hearings (hereinafter “DOAH”).

DOAH retained jurisdiction of this case on June 9, 2010. However, on June 15, 2010, prior to a formal hearing, Petitioner filed a Notice of Voluntary Dismissal. Since this notice was filed, DOAH entered an order on June 16, 2010 relinquishing jurisdiction back to the Department (see attached Exhibit A).

In light of the foregoing, the Petition filed by Hazel J. White is hereby dismissed with prejudice.
