1. Respondent's first Exception – "The Recommended Order Explicitly Recognizes the Controlling Standard but Fails to Apply it to the Facts of this Case" – is hereby rejected.

- 2. Respondent's second Exception "The School Board's Rules for Evaluation of Teachers were Honored more in the Breach than in the Observance" is hereby rejected.
- 3. Respondent's third Exception "Hearsay Alone Cannot Support a Finding, (A) Arthur Ashe Middle School was a Dangerous Place" is hereby rejected.
- 4. Respondent's fourth Exception "Hearsay Alone Cannot Support a Finding, (B) The Alleged Complaints" is hereby rejected.
- 5. Respondent's fifth Exception "The Recommended Order makes Findings Contradicted by The School Board's Own Evidence" is rejected.
 - 6. The Administrative Law Judge's Recommended Order is adopted in its entirety.

WHEREFORE, based on the foregoing, THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA, sustains the suspension of Sean Gentile without pay and hereby terminates her employment with The School Board of Broward County, Florida.
