## **FINAL ORDER**

THIS CAUSE is before me for entry of a final order. The recommended order finds that the Department established that respondents, a licensed child care facility and its owner/operator, violated minimum standards applicable to child care facilities provided in chapter 402, Florida Statutes, and chapter 65C-22, Florida Administrative Code. The administrative law judge recommended that the Department impose a \$500 fine and place respondents' license in probationary status for six months for the proven violations described in the recommended order. No exceptions to the recommended order were filed.

The recommended order is approved and adopted.

Accordingly, a \$500 fine is imposed upon respondents for the child care facility minimum standards violations described in the recommended order, and

the facility license is placed in probationary status for a period of six months.
