FINAL ORDER

Respondent shall pay an administrative fine of \$1,000.00 made payable to the Division of Pari-Mutuel Wagering, Department of Business and Professional Regulation, 1940 North Monroe Street, Tallahassee, FL 32399, within thirty (30) days of the date of the filing of this Final Order with the Department's Agency Clerk.

2. Respondent's license is suspended for a period of one year from the date of the filing of this Final Order with the Department's Agency Clerk.
