AMENDED FINAL ORDER AND NOTICE OF RIGHTS

The Office of Financial Regulation ("Office"), being authorized and directed to administer and enforce Chapter 560, Florida Statutes, and having reviewed the record and Recommended Order in this case, hereby enters this Amended Final Order.

FINDINGS OF FACT

- 1. The Office is the agency charged with the administration and enforcement of Chapter 560, Florida Statutes.
- 2. On January 27, 2011, the Office entered the attached Final Order (*Exhibit 1*) adopting the Administrative Law Judge's Recommended Order in this case. The Final Order ordered the Respondent to pay a \$3,000 fine within 30 days of the Final Order.
- 3. On or about February 8, 2011, the Respondent contacted the Office and requested to pay the \$3,000 fine in installments.

<u>AMENDED FINAL ORDER</u>

Having reviewed the record in this matter, the foregoing findings of fact are hereby adopted and it is accordingly ORDERED:

1. Paragraph 2 of the Final Order is modified as follows:

- 2. Respondent shall pay an administrative fine in the amount of THREE THOUSAND DOLLARS (\$3,000.00), with the submission of an initial payment of \$1,000 within thirty (30) days of this Amended Final Order, and subsequent payments of \$500.00 every thirty (30) days afterwards, until all \$3,000.00 have been paid. This administrative fine shall be submitted in the form of a cashier's check or money order made payable to the Department of Financial Services, and sent to the attention of Agency Clerk, Office of Financial Regulation, P.O. Box 8050, Tallahassee, Florida 32314-8050.
- 2. All other terms of the Final Order remain in effect.
