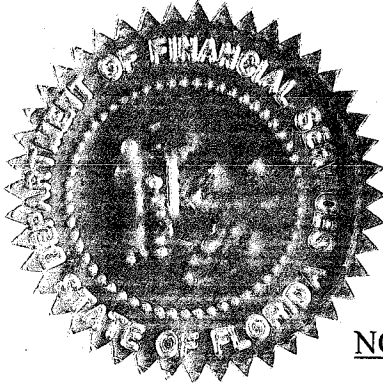
Therefore, after review of the record, including admitted exhibits, and being otherwise fully apprised in all material premises,

IT IS HEREBY ORDERED that the Findings of Fact of the Administrative Law Judge are adopted in full and incorporated herein by reference as the Department's Findings of Fact, and the Conclusions of Law reached by the Administrative Law Judge are adopted in full and incorporated herein by reference as the Department's Conclusions of Law.

IT IS HEREBY FURTHER ORDERED that the Recommendation made by the Administrative Law Judge is adopted in part by the Department, and is modified to the extent it is inconsistent with Section 648.50(1), Florida Statutes, which provides that upon the revocation of any bail bond agent license, the Department shall revoke all other licenses or appointments issued under the Florida Insurance Code, and the eligibility to hold such licenses or appointments. Accordingly, all licenses and appointments held by AHIZER ALVAREZ under

the Florida Insurance Code, and the eligibility to hold such licenses and appointments, are hereby REVOKED.
