ORDERED:

1. The attached Settlement Agreement is approved and adopted as part of this Final Order, and the parties are directed to comply with the terms of the Settlement Agreement.

2. Respondent shall pay an administrative fine in the amount of Seven Hundred Dollars (\$750.00). The administrative fine is due and payable within thirty (30) days of the date of rendition of this Order.
