## BACKGROUND

This is a proceeding to determine whether the Nassau County Comprehensive Plan Amendment 10-2ER, adopted by Ordinance 2010-11 on October 18, 2010, is "in compliance" with the Community Planning Act, Ch. 163, Part II, Florida Statutes.

The Department, the County, and Terrapointe LLC entered into a Stipulated Settlement Agreement which required the County to adopt certain remedial amendments for the 10-2ER amendment. The County adopted the remedial amendments on May 23, 2011, by Ordinance 2011-04, and after review of the amendment the Department posted its Remedial Cumulative Notice to find the amendments in compliance on the DCA website.

The issues raised in this case have been fully resolved. No additional remedial actions are required for the 10-2ER amendment to be in compliance. Intervenors Ray Roberts, Eric Titcomb, Robert Weintraub, and Julie Ferreira have dismissed their petition challenging the 10-2ER amendment. By Order in this case jurisdiction was relinquished to the Department by the Administrative Law Judge, and the DOAH file was closed.

#### <u>ORDER</u>

WHEREFORE, it is ORDERED that the Nassau County 10-2ER Plan Amendment adopted by Ordinance 2010-11 on October 18, 2010, as modified by the remedial amendment adopted by Ordinance 2011-04 on May 23, 2011, is "in compliance" with the Community Planning Act, Ch. 163, Part II, Florida Statutes.

A COPY OF THE NOTICE OF APPEAL MUST BE FILED WITH THE APPROPRIATE DISTRICT COURT OF APPEAL AND MUST BE ACCOMPANIED BY THE FILING FEE SPECIFIED IN SECTION 35.22(3), FLORIDA STATUTES.
