APPROVING RECOMMENDED ORDER**



In order to appeal, a party must file a notice of appeal with Lyn Lego, the Agency Clerk of the School Board of Manatee County, Florida, at 215 Manatee Avenue West, Bradenton, Florida 34205, within thirty (30) days of the rendition of this order and must also file a copy of the notice, accompanied by filing fees, with the Clerk of the Second District Court of Appeal, 1005 East Memorial Blvd., Lakeland, Florida 33801, telephone number (863)499-2290. Review proceedings shall be conducted in accordance with the Florida Appellate Rules, and specifically, Rule 9.110 of such Florida Appellate Rules.
