FINAL ORDER

This matter was considered by the Executive Director of the Department of Economic Opportunity following receipt of a Recommended Order issued by an Administrative Law Judge ("ALJ") of the Division of Administrative Hearings ("DOAH").

<u>BACKGROUND</u>

This is a proceeding to determine whether amendments to the Manatee County

Comprehensive Plan adopted by Ordinance No. 11-01 on August 4, 2011, (the "Plan

Amendments") are "in compliance" with the Community Planning Act, Ch. 163, Part II, Florida

Statutes (2011) (the "Act").

ROLE OF THE DEPARTMENT

Since the Recommended Order recommends that the Plan Amendments be found in compliance, the ALJ submitted the Recommended Order to the Department. § 163.3184(5)(e), Fla. Stat. (2011)¹. The Executive Director of the Department must either determine that the Plan Amendments are in compliance and enter a Final Order to that effect, or determine that the Plan

Amendments are not in compliance and submit the Recommended Order to the Administration Commission for final agency action. No exceptions were filed.

After review of the Recommended Order and the record, the Executive Director accepts the recommendation of the ALJ and determines that the Plan Amendments are in compliance.

<u>ORDER</u>

IT IS THEREFORE ORDERED as follows:

- 1. The findings of fact and conclusions of law in the Recommended Order are ADOPTED.
 - 2. The Administrative Law Judge's recommendation is ACCEPTED.
- 3. The amendments to the Manatee County Comprehensive Plan adopted by Ordinance No. 11-01 on August 4, 2011 are determined to be "in compliance" as defined in Section 163.3184(1)(b), Florida Statutes.
