FINAL ORDER

THIS CAUSE came before THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA on March 11, 2013, to consider (1) the Recommended Order entered on October 22, 2012, by Claude B. Arrington, Administrative Law Judge (hereinafter "ALJ") of the State of Florida Division of Administrative Hearings; (2) Respondent's Exceptions to the Recommended Order; and (3) Petitioner's Response to the Respondent's Exceptions.

THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA, having reviewed the entire record and transcript, and having heard oral arguments presented by representatives on behalf of the parties, and being fully advised in the Premises:

IT IS THEREUPON ADJUDGED that:

- The School Board rejects Respondent's first Exception as to Findings of Fact No.
 and No. 12.
- 2. The School Board rejects Respondent's second Exception as to Finding of Fact No. 13.
- 3. The School Board rejects Respondent's third Exception as to Conclusion of Law No. 31.

- 4. The Recommended Order is adopted in its entirety and is incorporated herein by reference.
 - 5. The School Board hereby:
 - a. Adopts the Findings of Fact and Conclusions of Law of the Recommended Order;
 - b. Finds Respondent, Leslie Rainer guilty of misconduct in office;
 - c. Suspends Respondent for a period of five (5) school days;
 - d. Requires Respondent to undergo diversity training to be determined by The School Board within 60 days of the entry of this Order; and
 - e. provides that the Respondent's fringe benefits (such as health insurance) will not be disturbed during the period of suspension.
