FINAL ORDER

 - b. Dismisses Respondent's charges sections 1002.20, 1002.22, and 1012.33, Broward County School Board policy 5100.1, 20 U.S.C.A. section 1232(g), and rules 6(B)-1.001, 6(B)-1.006(3)(f),(h),(i), 4(b), 5(a), and 6(A)-1.0955, 6(B)-4.009(1)(2) and (3); and

- c. Immediately reinstates Respondent Richard Allen.
- 3. The School Board shall:
 - (a) Provide Respondent, Richard Allen, with a written reprimand for the three violations; and
 - (b) Issue Respondent back salary.
- 4. Petitioner's Motion to Relinquish Jurisdiction and Remand the Case to the Department of Administrative Hearings (DOAH) is denied as moot.
