FINAL ORDER

This matter came before the Criminal Justice Standards and Training Commission (the Commission) at a public meeting on January 31, 2013, in St. Augustine, Florida. It was alleged by Administrative Complaint that the Respondent had violated specified sections of Chapter 943, Florida Statutes, and Chapter 11B-27, Florida Administrative Code. In accordance with §§120.569 and 120.57(1), Florida Statutes, a formal hearing was held on this matter, and a Recommended Order was submitted by an administrative law judge from the Division of Administrative Hearings to the Commission for consideration. Counsel for Petitioner filed exceptions to the Recommended Order, a copy of which is attached and incorporated herein by reference.

The Commission, having reviewed the Administrative Complaint and the Recommended Order, and being otherwise fully advised in this matter, approves and adopts as its own the administrative law judge's finding of fact and conclusions of law as set forth in the Recommended Order. The Commission further rejects the administrative law judge's recommended penalty and accepts

staff counsel's exceptions to the recommended penalty and REVOKE respondent's certification.

It is therefore ORDERED AND ADJUDGED that the Respondent's above referenced criminal justice certification is hereby REVOKED.

This Final Order will become effective upon filing with the Clerk of the Department of Law Enforcement.
