FINAL ORDER

On June 26, 2012, Petitioner DeSoto County School Board ("the Board") voted unanimously to terminate Respondent John B. Sculley's ("Sculley") employment, finding that just cause existed based upon facts it had reviewed. Sculley timely filed a request for a formal administrative hearing before the Division of Administrative Hearings to contest the Board's decision. An administrative hearing was held in Arcadia, Florida, on October 29, 2012, before R. Bruce McKibben, a duly-appointed Administrative Law Judge.

The Board's Exhibits 1 through 14 were accepted into evidence. Sculley presented one witness, Dr. Roosevelt Johnson. Respondent offered Exhibits 1 through 4 into evidence, each of which was accepted. The Recommended Order was entered on January 7, 2013. No exceptions were filed.

STATEMENT OF THE ISSUE

As stated in the Recommended Order, the issue presented was whether just cause exists to terminate the employment of Respondent, John B. Sculley. Petitioner, DeSoto County School Board, alleged that Sculley violated Florida Administrative Code Rule 6A-5.056(2), i.e., that he was incompetent in the performance of his duties as a school psychologist.

FINDING OF FACT

The Administrative Law Judge's Findings of Fact in paragraphs 1 through 24 are supported by competent, substantial evidence and are adopted and incorporated as if fully set forth herein.

CONCLUSIONS OF LAW

1. The Board has jurisdiction over the subject matter of and the parties to this proceeding pursuant to Chapters 120 and 1012, Florida Statutes.

2. The Conclusions of Law in paragraphs 25 through 34 of the Recommended Order are fully supported in law, and are adopted and incorporated as if fully set forth herein.

Based upon the foregoing Finding of Fact and Conclusions of Law, it is

ORDERED that the Recommended Order is adopted in its entirety and incorporated herein by reference. It is further

ORDERED that the Board's termination of Sculley's employment, effective June 26, 2012, is SUSTAINED.
