## FINAL ORDER DISMISSING REQUEST FOR ATTORNEY FEES AND COSTS

On Friday, July 24, 2015, the Commission on Ethics met in public session and considered this matter, finding as follows:

1. Commission on Ethics Complaint No. 11-058, In re MYRON ROSNER, was dismissed with a finding of no probable cause via the Commission's Public Report rendered August 1, 2012.

2. Thereafter, the Respondent, Myron Rosner, filed with the Commission a request for attorney fees and costs against the Complainant, Jarrett L. Gross.

3. The Commission's staff evaluated the request and transmitted it to the Division of Administrative Hearings (DOAH) for assignment of an Administrative Law Judge (ALJ) and the conducting of a hearing on the request.

4. While the matter was at DOAH, a Settlement Agreement And Mutual Release was entered into, resulting in the closure of the DOAH file on the matter and relinquishment of the matter to the Commission on Ethics.

Accordingly, the fees/costs matter having been settled, the request for fees and costs in this matter is hereby dismissed and the Commission's file on the matter is closed.<sup>1</sup>
