FINAL ORDER

Findings of Fact

- The Administrative Law Judge's findings of fact as set forth in Exhibit "A" are approved, adopted, and incorporated herein by reference.
- There is competent, substantial evidence to support the Administrative Law Judge's findings of fact as adopted by the Commission.

Conclusions of Law

3. The Commission has jurisdiction of this matter pursuant to Sections 120.569 and 120.57(1), Florida Statutes, Chapter 475, Part I, Florida Statutes, and Chapter 61J2 of the Florida Administrative Code.

4. The Administrative Law Judge's conclusions of law as set forth in Exhibit "A" are approved, adopted, and incorporated

5. There is competent, substantial evidence to support the Administrative Law Judge's conclusions of law in Exhibit "A" as amended and adopted by the Commission.

DISPOSITION

6. The Administrative Law Judge's Recommendation is approved and adopted by the Commission in its entirety. WHEREFORE, IT IS HEREBY ORDERED and ADJUDGED that:

- (a) Respondent shall pay a fine of \$2,500.00 by the end of the 30 day suspension period as described below for violating Section 475.25(1)(b), F.S., and mail to the Division of Real Estate, Zora Neale Hurston Building, 400 W. Robinson Street, Suite N801, Orlando, Florida 32801.
- (b) Respondent's license is SUSPENDED for 30 days beginning 30 days from the filing date of this Final Order.
