FINAL ORDER

THIS CAUSE is before me for entry of a final order. The recommended order finds respondent committed a class II licensing violation related to staff background screening as alleged in the Department's December 7, 2012, administrative complaint, but concludes the Department did not prove respondent, on August 27, 2012, violated minimum standards for staff-to-child ratios. The administrative law judge recommended the Department impose a \$50 fine for the screening violation. Neither party filed exceptions to the recommended order.

The recommended order is approved and adopted.

Accordingly, respondent is fined \$50 for the child care minimum standards violation described in the recommended order.

REVIEW PROCEEDINGS SHALL BE CONDUCTED IN ACCORDANCE WITH THE FLORIDA RULES OF APPELLATE PROCEDURE. THE NOTICE OF APPEAL MUST BE FILED WITHIN 30 DAYS OF RENDITION OF THE ORDER TO BE REVIEWED.


