THIS CAUSE is before me for entry of a final order. The recommended order finds the Department presented clear and convincing evidence establishing petitioner violated child care licensing minimum standards in sections 402.305 and 435.05, Florida Statutes, and chapter 65C-22, Florida Administrative Code. The administrative law judge recommended the Department deny petitioner's application to renew her child care license. Neither party filed exceptions to the recommended order.

The recommended order is approved and adopted.

Accordingly, petitioner's application to its child care facility license is DENIED.

REVIEW PROCEEDINGS SHALL BE CONDUCTED IN ACCORDANCE WITH THE FLORIDA RULES OF APPELLATE PROCEDURE. THE NOTICE OF APPEAL MUST BE FILED WITHIN 30 DAYS OF RENDITION OF THE ORDER TO BE REVIEWED.


