

# FINAL ORDER OF DISMISSAL

On or about January 16, 2013, the Agency for Persons with Disabilities filed a Notice of License Application Denial denying Respondent Jabez House, Owned and Operated by Serenity Holistic Residential Care, Corp. a license as a group home facility due to violation of section 419.001(2), Florida Statutes, rule 65G-2.015(3), F.A.C., rule 65G-2.015(7), F.A.C. and failure to get location approval from the appropriate local government unit.

On February 18, 2013, counsel for Petitioner filed a Motion for Voluntary Withdrawal of Notice of Denial. The basis of the Motion was that the Denial would be withdrawn due to documents that show that the county approved of the proposed group home location. On February 19, 2013, the ALJ issued an Order Closing File and Relinquishing Jurisdiction.

Based on the foregoing and being otherwise fully advised in the premises, it is hereby ORDERED that Respondent's request for an administrative hearing is DISMISSED, the Notice of Application Denial is withdrawn, and this case is closed.
