MOTION TO ASSESS COSTS IN ACCORDANCE WITH SECTION 456.072(4)

COMES NOW the Department of Health, by and through undersigned counsel, and moves the Board of Nursing for the entry of a Final Order assessing costs against the Respondent for the investigation and prosecution of this case in accordance with Section 456.072(4), Florida Statutes. As grounds therefore, the Petitioner states the following:

1. At the August 1, 2013, regularly scheduled Board meeting, the Board of Nursing voted to impose discipline in the above-styled disciplinary action. At the Board meeting, the Department's request for the assessment of costs related to the

investigation and prosecution of the case against Respondent were bifurcated and held for future consideration by the Board.

2. Section 456.072(4), Florida Statutes, states as follows:

In addition to any other discipline imposed through final order, or citation, entered on or after July 1, 2001, pursuant to this section or discipline imposed through final order, or citation, entered on or after July 1, 2001, for a violation of any practice act, the board, or the department when there is not board, shall assess costs related to the investigation and prosecution of the case. Such costs related to the investigation and prosecution include, but are not limited to, salaries and benefits of personnel, costs related to the time spent by the attorney and other personnel working on the case, and any other expenses incurred by the department for the case. The board, or the department when there is no board, shall determine the amount of costs to be assessed after its consideration of an affidavit of itemized costs and any written objections thereto. . . .

- 3. As evidenced in the attached affidavit (Exhibit A, Exhibit 1, Exhibit 2), the investigation and prosecution of this case has resulted in costs in the total amount of following itemized statement of costs:
 - a. Total costs for Complaints \$121.00
 - b. Total costs for Investigations, \$1,682.37
 - c. Total costs for Legal, \$5,732.64
 - d. Total costs for Compliance \$0.00
- 4. The attached affidavit from the Department attorney assigned to this case (Exhibit B) attests that the time and costs incurred in prosecuting this case are reasonable and justifiable.
- 5. The attached affidavit from an outside attorney (ExhibitC) attests that the Department's costs for attorney time in this case are reasonable and justifiable.
- 6. Should Respondent file written objections to the assessments of costs, within ten (10) days of the date of this motion, specifying the grounds for objections and the specific elements of the costs to which objections are made, Petitioner requests that the Board determine the amount of costs to be assessed based upon its

consideration of the affidavits attached as Exhibits A (with Exhibits 1 and Exhibit 2), B, and C and any timely-filed written objections.

7. Petitioner requests that the Board grant this motion and assess costs in the amount of \$8,154.47 as reasonable and justifiable and supported by competent substantial evidence. This assessment of costs is in addition to any other discipline imposed by the Board and is in accordance with Section 456.072(4), Florida Statutes (2012).

WHEREFORE, the Department of Health requests that the Board of Nursing enter a Final Order assessing costs against Respondent in this matter in the amount of \$8,154.47.
