THIS CAUSE came before the Court upon the Recommended Order dated March 4, 2014 and entered by J. D. Parrish, Administrative Law Judge, Division of Administrative Hearings, wherein Judge Parrish recommended an order be entered by this Court that the Defendant failed to establish his actual innocence for purposes of the Victims of Wrongful Incarceration Compensation Act (Exhibit A, Recommended Order).
