FINAL ORDER


THIS CAUSE is before me for entry of a final order. The recommended order finds the Department proved repeated serious violations of child care licensing minimum standards provided in chapter 402, Florida Statutes, and chapter 65C-22, Florida Administrative Code. The administrative law judge concluded the Department appropriately proposed to revoke respondent's existing child care facility license, and appropriately proposed to deny respondent's application to renew the license. Neither party filed exceptions to the recommended order.

The recommended order is approved and adopted.

Accordingly, respondent's license to operate a child care facility is REVOKED, and respondent's application to renew its license to operate a child care facility is DENIED.

A PARTY WHO IS ADVERSELY AFFECTED BY THIS FINAL ORDER IS ENTITLED TO JUDICIAL REVIEW WHICH SHALL BE INSTITUTED BY FILING ONE COPY OF A NOTICE OF APPEAL WITH THE AGENCY CLERK OF THE DEPARTMENT OF CHILDREN AND FAMILIES, AND A SECOND COPY ALONG WITH FILING FEE AS PRESCRIBED BY LAW, IN THE DISTRICT COURT OF APPEAL WHERE THE APPELLANT RESIDES, OR IN THE FIRST DISTRICT COURT OF APPEAL. REVIEW PROCEEDINGS SHALL BE CONDUCTED IN ACCORDANCE WITH THE FLORIDA RULES OF APPELLATE PROCEDURE. THE NOTICE OF APPEAL MUST BE FILED WITHIN 30 DAYS OF RENDITION OF THE ORDER TO BE REVIEWED.


