This proceeding was initiated by the Petitioner's request for an administrative hearing. This matter is before Department of Health for consideration of a Recommended Order.



The Recommended Order advised both parties that they may file exceptions to the findings of fact and/or conclusions of law contained in the Recommended Order with the Department of Health, Agency Clerk, within fifteen (15) days of the filing of the Recommended Order. Neither party timely filed exceptions to the Hearing Officer's Recommended Order.

Based on the foregoing, the Petitioner is ORDERED to repay the overpayment of salary in the amount of \$2,980.04. Payment in full is due no later than 10 days from the date of filing this final order.
