FINAL ORDER OF DISMISSAL

On July 16, 2013, the Department of Education issued a Notice of Denial of Application to Participate in Educational Scholarship Programs alleging that Hidden Treasure Preschool Christian Academy (“the School”) had violated certain provisions of applicable law as it relates to the School’s eligibility and participation in the John M. McKay Scholarship for Students with Disabilities Program (“McKay”) and the Florida Tax Credit Scholarship Program (“FTC”). The School timely submitted a request for a formal administrative hearing on the allegations. Subsequently, pursuant to § 120.57(4), Fla. Stat., the School and Commissioner entered into the attached Settlement Agreement, to resolve and settle all matters arising from the Denial, which is incorporated by reference and shall take effect as of the date of this Order.

DISPOSITION

IT IS THEREFORE ORDERED, that this case is hereby dismissed.

NOTICE OF RIGHTS


