FINAL ORDER

THIS CAUSE came on for consideration of and final agency action on the Amended Recommended Order, (Exhibit A), issued on March 31, 2014, amended as to the December Hearing date only, of the Recommended Order issued March 28, 2014. The Amended Recommended Order does not affect the recommendation of the Recommended Order, dated March 28, 2014.

On August 27, 2013, the Department of Financial Services, Division of Agents and Agency Services issued a one-count Administrative Complaint against MARTA R. DE LA PAZ (DE LA PAZ), for violation of certain alleged provisions of Chapter 626, Florida Statutes, and seeking revocation of DE LA PAZ's insurance agent license. DE LA PAZ timely requested a formal hearing.

Pursuant to Section 120.57(1), Florida Statutes, a formal hearing was conducted by video teleconference on December 4, 2013, and January 7, 2014, before Administrative Law Judge Mary Li Creasy, in Tallahassee, Florida, and Miami, Florida, via video teleconference. The Recommended Order recommended that the Administrative Complaint be dismissed for the reasons set forth therein. No exceptions were filed.

After review of the record, including the transcript of proceedings and admitted exhibits, and being otherwise fully apprised in all material premises,

IT IS HEREBY ORDERED that the ALJ's Findings of Fact and Conclusions of Law set forth in the Recommended Order are adopted as the Department's Findings of Fact and Conclusions of Law.

IT IS HEREBY FURTHER ORDERED that the charges in Administrative Complaint filed August 27, 2013, against MARTA R. DE LA PAZ are hereby dismissed.
