# FINAL ORDER

THIS CAUSE came before the BOARD OF NURSING (Board) pursuant to Sections 120.569 and 120.57(1), Florida Statutes, on June 5, 2014, in Jacksonville, Florida, for the purpose of considering the Administrative Law Judge's Recommended Order (a copy of which is attached hereto as Exhibit A) in the above-styled cause. Petitioner was represented by Matthew G. Witters, Assistant General Counsel. Respondent was present pro se.

Upon review of the Recommended Order, the argument of the parties, and after a review of the complete record in this case, the Board makes the following findings and conclusions.

# RULING ON RESPONDENT'S REQUEST FOR EXCEPTIONS TO RULING

Respondent filed a Request for Exceptions to Ruling. pleading does not meet the requirements of Rule 28-106.217, Florida Administrative Code. The pleading does not identify the disputed findings of the Recommended Order, does not identify those findings by citation, does not set forth the legal basis for any exceptions

and does not cite to the record. The Request for Exceptions to Ruling is therefore denied.

### FINDINGS OF FACT

- 1. The findings of fact set forth in the Recommended Order are approved and adopted and incorporated herein by reference.
- 2. There is competent substantial evidence to support the findings of fact.

# CONCLUSIONS OF LAW

- 1. The Board has jurisdiction of this matter pursuant to Section 120.57(1), Florida Statutes, and Chapter 464, Florida Statutes.
- 2. The conclusions of law set forth in the Recommended Order are approved and adopted and incorporated herein by reference.

#### PENALTY

Upon a complete review of the record in this case, the Board determines that the penalty recommended by the Administrative Law Judge be ACCEPTED. WHEREFORE, IT IS HEREBY ORDERED AND ADJUDGED: The license of DARLINE SUE PEGUERO is suspended until the she undergoes an evaluation coordinated by the Intervention Project for Nurses (IPN), and complies with any and all terms and conditions imposed by IPN as a result of said evaluation. It is the duty of the licensee to contact the IPN at P.O. Box 49130, Jacksonville Beach, Florida 32240-9130, (904) 270-1620 within 30 days. If the licensee is not in need of monitoring or treatment and the IPN is not suitable, no further action will be required.

# RULING ON MOTION TO ASSESS COSTS

The Board reserves jurisdiction to rule on Petitioner's Motion to Assess Costs.
