## FINAL ORDER ADOPTING THE FINDINGS OF FACT AND CONCLUSIONS OF LAW OF THE ADMINISTRATIVE LAW JUDGE

Pursuant to notice, a formal hearing was held in this matter on April 1, 2014, before the Division of Administrative Hearings by Administrative Law Judge David M. Maloney via video teleconference at sites located in Tallahassee and Pensacola, Florida. The subject matter of the hearing was whether the School Board should permit Respondent to take sick leave for the period commencing December 18, 2013, through the time it takes for evaluation by a Substance Abuse Professional and any necessary rehabilitation; or until Respondent's sick leave is exhausted, whichever occurs first.

Judge Maloney issued a Recommended Order on May 2, 2014. Judge Maloney concluded that Respondent failed to meet the burden of proof that substance abuse in general or abuse of opiates, in particular is a sickness. Judge Maloney concluded that Respondent failed to meet the burden of proof that she is entitled to sick leave for substance abuse after returning to work from suspension without pay for a first-time, positive, drug test. Judge Maloney made findings of fact and conclusions of law, which are supported by the record.

Pursuant to Section 120.57, Florida Statutes, the School Board of Escambia County hereby adopts the findings of fact and conclusions of law contained in the Recommended Order, which is specifically incorporated by reference and attached. The Respondent's request to be allowed to use sick leave during her suspension without pay is hereby DENIED.
