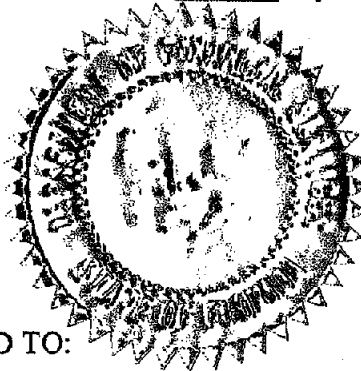
FINAL ORDER

NOTICE OF RIGHT TO JUDICIAL REVIEW

Any person adversely affected by this Order is entitled to seek judicial review of this Order pursuant to §120.68, Florida Statutes. Review proceedings are governed by the Florida Rules of Appellate Procedure. Such proceedings are commenced by filing an original notice of appeal with Julie Jones, CP, FRP, DFS Agency Clerk, Department of Financial Services, 612 Larson Building, 200 E. Gaines Street, Tallahassee, Florida 32399-0390, and a copy of the same accompanied by the filing fees prescribed by §35.22 Florida Statutes, with the First District Court of Appeal, 2000 Drayton Drive, Tallahassee, FL 32399-0950, or with the District Court of Appeal in the appellate district where the party resides. The Notice of Appeal must be filed within 30 days of rendition of the order to be reviewed.
