THIS CAUSE is before me for entry of a final order. The Recommended Order finds the Department proved respondent violated several provisions of sections 402.310 – 402.319, Florida Statutes, and chapter 65C-22, Florida Administrative Code, as alleged in an amended administrative complaint issued in February 2014. The Administrative Law Judge recommended the Department assess a \$200 fine, convert the Respondent's license to probationary status and terminate Respondent's Gold Seal status. Neither party filed exceptions to the recommended order.

The Recommended Order is approved and adopted.

Accordingly, Respondent is fined \$200, Respondent's child care facility license is converted to probationary status and Respondent's Gold Seal status is terminated.


