This matter, having come before the Pinellas County Sheriff's Civil Service Board, sitting as a quasi-judicial body, and the Board having reviewed the Administrative Law Judge's July 21, 2014 Order Closing File And Relinquishing Jurisdiction, and being otherwise advised in the premises, it is:

ORDERED AND ADJUDGED that:

- 1. The Board, by a unanimous vote of five (5) members finds that Respondent Adrian Nenu engaged in prohibited conduct in that Respondent violated Petitioner's General Order 3-1.1, Rule and Regulation 5.4, (Duties and Responsibilities) and General Order 3-1.3, Rule and Regulation 3.36 (Omission of Information).
- 2. The seven day suspension of Respondent's employment with the Pinellas County Sheriff's Office is upheld.
- 3. The parties are hereby notified of the right to appeal this Final Order to the Second District Court of Appeal by filing notice of intent to do so upon the Clerk of Court and the Pinellas County Sheriff's Civil Service Board within thirty (30) days of the date of this Order.
