**AGREED FINAL ORDER**

This cause came on to heard on June 1, 2015, before the School Board of Lake County, Florida (hereinafter "School Board") to consider: the above referenced matter; the Recommended Order consisting of Findings of Fact, Conclusions of Law, and a Recommendation rendered on March 26, 2015 by the Honorable Edward T. Bauer, Administrative Law Judge of the Florida Division of Administrative Hearings; the Exceptions filed by the Petitioner; and the proposed Settlement Agreement filed by the Parties, and School Board being otherwise fully advised in the premises does hereby determine as follows:

1. The Parties have filed a Settlement Agreement in which the Parties have agreed to the entry of this Agreed Final Order by the School Board. The Settlement Agreement is incorporated herein by reference.
2. The Parties have waived their right to any appeal or judicial review of this Agreed Final Order that would have been available under section 120.68, Florida Statutes.

3. In compliance with the Settlement Agreement, the Petitioner hereby withdraws its Exceptions to the Recommended Order that were filed in these proceedings.
4. In compliance with the Settlement Agreement, the Respondent hereby withdraws his request for an administrative hearing to challenge his recommended termination, thus obviating the need for the School Board to take action on the Recommended Order.
5. This matter is therefore dismissed.
