FINAL ORDER OF DISMISSAL



NOTICE OF RIGHTS



Notice of Appeal must be filed within 30 days of the day this Order is filed with the Clerk of the Commission.

**PETITIONER'S NOTICE OF WITHDRAWING PETITION TO AMEND THE
BOUNDARY OF THE RIVER HALL COMMUNITY DEVELOPMENT DISTRICT**

Petitioner, River Hall Community Development District, by and through its undersigned counsel, hereby gives Notice of Withdrawing its Petition to Amend the Boundary of the River Hall Community Development District, effective as of the date of this notice. Accordingly, the District respectfully requests that all rulemaking proceedings regarding this matter be discontinued immediately, as withdrawal of the Petition by the District divests the Commission of jurisdiction to proceed and effectively terminates all proceedings in this matter. See Orange County v. Debra, Inc., 451 So.2d 868 (Fla. 1st DCA 1983) (holding withdrawal of petition submitted pursuant to Chapter 190 deprives the Commission of jurisdiction to proceed).
