FINDINGS OF FACT

1. The Administrative Law Judge's findings of fact as set forth in the Exhibit "A" are approved, adopted and incorporated herein by reference.

2. There is competent, substantial evidence to support the Administrative Law Judge's findings of fact as adopted by the Commission.

CONCLUSIONS OF LAW

3. The Commission has jurisdiction of this matter pursuant to Sections 120.569 and 120.57(1), Florida Statutes, Chapter 475, Part 1, Florida Statutes, and Chapter 61J2 of the Florida Administrative Code.

4. The Administrative Law Judge's conclusions of law as set forth in Exhibit "A" are approved, adopted and incorporated herein by reference. The is competent, substantial evidence to support the conclusions of law in the Recommended Order.

EXCEPTIONS

5. Respondent's Exception to the Recommended Penalty was considered and DENIED.

DISPOSITION

Upon a complete review of the record, the Commission finds that Respondent violated
Sections 475.25(1)(a), 475.25(1)(b), 475.25(1)(d), 475.25(1)(k), 475.42(1)(a), 475.42(1)(d),
Florida Statutes, as set forth in the Amended Administrative Complaint.

WHEREFORE, it is hereby ORDERED and ADJUDGED that:

1. Respondent is in violation of all counts of the Amended Administrative Complaint;

2. Respondent's license is REVOKED;

3. Respondent shall pay a fine of \$10,000.00 within 30 days of the filing date of this Final Order.

This Order is effective when filed with the Clerk of the Department of Business and Professional Regulation.
