## **FINAL ORDER**

Having reviewed the Administrative Complaint and Notice of Intent to Deny, and all other matters of record, the Agency for Health Care Administration finds and concludes as follows:

- 1. The Agency has jurisdiction over the above-named Provider pursuant to Chapter 408, Part II, Florida Statutes, and the applicable authorizing statutes and administrative code provisions.
- 2. The Agency issued the attached Administrative Complaint and Election of Rights forms to the Provider. (Ex. 1) The Agency also issued the attached Notice of Intent to Deny Renewal Application and Election of Rights form to the Provider. (Ex. 2) The Election of Rights forms advised of the right to an administrative hearing.
  - 3. The parties have since entered into the attached Settlement Agreement. (Ex. 3)

Based upon the foregoing, it is **ORDERED**:

- 4. The Settlement Agreement is adopted and incorporated by reference into this Final Order. The parties shall comply with the terms of the Settlement Agreement.
- 5. The Provider shall contract with a consultant and fulfill its contractual obligations under the Settlement Agreement. The Provider's Administrator shall complete the ALF training for Limited Mental Health Licensure certification course.
- 6. The Provider shall pay the Agency \$2,500.00. If full payment has been made, the cancelled check acts as receipt of payment and no further payment is required. If full payment has not been made, payment is due within 30 days of the Final Order. Overdue amounts are subject to statutory interest and may be referred to collections. - 7. Counts II and III of the Administrative Complaint are withdrawn.
- 8. The Notice of Intent to Deny is withdrawn.
