FINAL ORDER

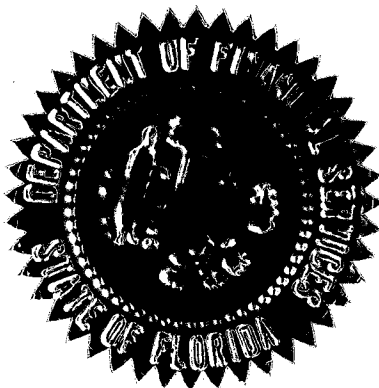
THIS CAUSE came on for consideration of and for final agency action on the Recommended Order issued on April 28, 2015, attached hereto as Exhibit A.

After a review of the record, including all admitted exhibits, and considering the applicable law, and otherwise being fully apprised in all material premises:

The findings of fact and conclusions of law in the Recommended Order are adopted in full. Further, the Administrative Law Judge's recommendation that a final order be entered imposing a penalty in the amount of \$19,818.04 is accepted.

Accordingly, Klenk Roofing, Inc., shall pay a penalty in the amount of \$19,818.04 or enter into a Payment Agreement Schedule for Periodic Payment of Penalty (minus any payments made to date), and the Agreed Order of Conditional Release from Stop-Work Order shall continue in effect, subject to its terms and conditions.

### NOTICE OF RIGHT TO APPEAL

A party adversely affected by this final order may seek judicial review as provided in section 120.68, Florida Statutes, and Florida Rule of Appellate Procedure 9.190. Judicial review is initiated by filing a notice of appeal with the Agency Clerk, and a copy of the notice of appeal, accompanied by the filing fee, with the appropriate district court of appeal. The notice of appeal must conform to the requirements of Florida Rule of Appellate Procedure 9.110(d), and must be filed (i.e., received by the Agency Clerk) within thirty days of rendition of this final order.
