THIS CAUSE is before me for entry of a final order. The Recommended Order finds that the Respondent did not have a pool alarm in its unfenced backyard pool, as charged, concluded that such failure was a violation of the requirements of Rule 65C-20.010(1)(i), Florida Administrative Code, and recommended imposition of a penalty of \$100 and termination of Respondent's Gold Seal Designation. Neither party filed exceptions.

The Recommended Order is approved and adopted.

Accordingly, a penalty of \$100 is imposed on Respondent and its Gold Seal Designation is terminated.

THE NOTICE OF APPEAL MUST BE FILED (RECEIVED) WITHIN 30 DAYS OF RENDITION OF THIS ORDER.<sup>1</sup>
