FINAL ORDER

THIS CAUSE comes before the Agency for Health Care Administration ("the Agency") concerning the Petition which was filed by CCRC OPCO-Freedom Square, LLC d/b/a Freedom Square Rehabilitation and Nursing Services (hereinafter "Freedom Square") challenging the preliminarily denial of a certificate of need ("CON") by the Agency to add 56 community nursing home beds through the conversion of 56 sheltered nursing home beds.

- 1. In the October 3, 2014, Florida Administrative Register, Volume 40, Number 193, the Agency published its intent to preliminarily deny CON Application 10286 filed by Freedom Square.
- 2. On March 13, 2015, Freedom Square filed a Petition for Formal Administrative Hearing with the Agency Clerk.
- 3. The Parties have since entered into a settlement agreement (Exhibit A) resolving this litigation.

Based upon the foregoing, it is **ORDERED**:

- 1. The Agency shall issue a CON for 56 community nursing home beds, which shall contain a condition that Freedom Square will make a nursing home bed available at Freedom Square nursing home facility to any resident for any such resident requiring a nursing home.
 - 2. Each party will be responsible for its own respective costs and attorney's fees.
- 3. Each party shall comply with the terms and condition of the settlement agreement the terms of which are incorporated herein by reference.
